NORMATIVE INSTRUCTION IN No. 84, OF MARCH 12TH, 2021

It provides for the list of medical devices selected for economic monitoring by Anvisa.

The Collegiate Board of Directors of the National Health Surveillance Agency, in the use of the attribution conferred on it by article 15, III and IV, together with article 7, III and IV of Law No. 9,782, of January 26th, 1999, and article 53, VII, §§ 1 and 3 of the Internal Regulations approved by the Collegiate Board Resolution - RDC No. 255, of December 10th, 2018, at a meeting held on March 11th, 2021, resolves:

Art. 1 The List of medical devices selected for economic monitoring by Anvisa is approved, in the form of the Annex, in accordance with the provisions of Collegiate Board Resolution No. RDC No. 478, of March 12th, 2021.

Art. 2 This Resolution enters into force on April 1st, 2021.
